Sirs:

Please read the letter to Speaker Pelosi in the attached pdf and our recent e-mail requests to Sen. McCain and Sen. Klobuchar reproduced at <http://www.enormouscrime.com/>. When you have read all correspondence and attachments, please order up all additional intelligence you have received on this prison for American POWs and begin planning for a no-notice inspection of it subject to the following caveat:

**CAVEAT: Given your past record of conducting and/or assisting with contrived, bogus, immoral, illegal and totally dishonest LSI's**—to mention just two: (1) Sen. John Kerry's and your Maj. Gen. Tom Needham's repugnant and disgusting faked "No-Notice LSI" of Bang Liet Prison in April 1992; and (2) your utterly shameful faked June/July 1995 "search for" and "live sighting investigation of" the Hung Hoa underground Supermax for American POWs, which, as everyone knows, is not located in a maize field along the south bank of the Red River near Hung Hoa as you claimed after your outrageous June/July 1995 "LSI," but deep inside a mountain in the extreme southeastern Hoang Lien Son Mountains south of Hung Hoa, where your own LTC Mel Richmond admitted to the press just prior to his faked "LSI" in the field in June/July 1995, "there are many caves" and therefore it might take him and his investigators "many weeks or months" to find the prison deep inside the mountain—**we insist that the two of us be brought to Hanoi immediately to show you exactly where the underground Supermax for American POWs in Hanoi is located and to accompany your investigators on every step of this historic Live Sighting Investigation.**
